Comes the affiant, CHRISTIE K. MEEKS,
after first being duly sworn, states the following.

- CKM 1. MY NAME IS CHRISTIE MEEKS I AM OVER THE AGE OF 18 AND AM COMPETENT TO MAKE THIS AFFIDAVIT EVERYTHING WRITTEN IN THIS AFFIDAVIT IS TRUE AND CORRECT AND BASED ON MY PERSONAL KNOWLEDGE.
- CKM 2. IN 1997 I TESTIFIED IN MICHAEL TONEY'S CAPITAL MURDER TRIAL. MY TESTIMONY ABOUT THE EVENTS THAT HAPPENED ON THANKSGIVING DAY 1985, MAY NOT HAVE HAPPENED ON THAT DAY, THE ONLY THING THAT I CAN REMEMBER THAT HAPPENED THAT DAY IS THAT I HAD THANKSGIVING DINNER WITH MY PARENTS AT THEIR HOME IN KELLERTX.
- CKM 3. I GAVE A STATEMENT TO ATF AGENT MS. JELERS ABOUT MY LACK OF KNOWLEDGE AS TO MY WHEREABOUTS ON THANKSGIVING DAY 1985.
- CKM 4. IF THERE ARE RECORDS SHOWING THAT THE TRUCK, TOOL BOX, AND GUNS WERE BOUGHT AFTER THANKSGIVING DAY 1985, THEN THESE EVENTS COULD HAVE HAPPENED AFTER THANKSGIVING DAY 1985.
- CKM 5. AT THE TIME I KNEW MICHAEL TONEY HE ALWAYS CARRIED THE SAME BRIEF CASE. TO MY KNOWLEDGE THE BRIEF CASE NEVER HAD ANY BOMBING MATERIAL INSIDE.
- CKM 6. I WAS NEVER INTERVIEWED BY MICHAEL'S ATTORNEY OR INVESTIGATOR. IF I HAD BEEN CONTACTED, I WOULD HAVE TOLD THEM THAT I HAD NO KNOWLEDGE ABOUT THE LAKE WORTH BOMBING ON THANKSGIVING DAY 1985.
- CKM 7. I WAS ASKED QUESTIONS FOR AT LEAST 3 DAYS AT ABOUT 12 HOURS A DAY BY ATF AGENTS. THIS IS HOW I BECAME AWARE OF THE LAKE WORTH BOMBING ON THANKSGIVING DAY 1985.
