CRIMINAL INFORMATION

The Assistant District Attorney in and for Lea County, State of New Mexico, states that on or about the 11th day of February, 1999, in said County and State, the above named defendant committed the following crimes, to-wit:

- COUNT I: DRIVING WHILE UNDER THE INFLUENCE OF INTOXICATING LIQUOR OR DRUGS, FOURTH OR SUBSEQUENT OFFENSE, in that the above named defendant, operated a motor vehicle within the State of New Mexico while under the influence of intoxicating liquor, after having three or more prior convictions under this section, contrary to Section 66-8-102, NMSA 1978; and
- COUNT II: DRIVING WHILE LICENSE SUSPENDED OR REVOKED, in that the above named defendant operated a motor vehicle on a public highway at a time when his privilege to do so was suspended or revoked, contrary to Section 66-5-39, NMSA 1978; and
- COUNT III: EVIDENCE OF REGISTRATION, in that the above named defendant failed to exhibit evidence of registration upon demand by a police officer, contrary to Section 66-3-13, NMSA 1978; and
- COUNT IV: NO INSURANCE, in that the above named defendant operated a motor vehicle on a state highway without carrying evidence of financial responsibility, contrary to Section 66-5-205, NMSA 1978.
- COUNT V: VEHICLES WITHOUT REQUIRED EQUIPMENT OR IN UNSAFE CONDITION, in that the above named defendant drove a vehicle on a highway while equipment on such vehicle was not in good working order and adjustment as required in the Motor Vehicle Code, contrary to Section 66-3-901, NMSA 1978; and

COUNT VI: CARELESS DRIVING, in that the above named defendant operated a motor vehicle in a careless, inattentive or imprudent manner, without due regard for width, grade, curves, corners, traffic, weather and road conditions and all other attendant circumstances, contrary to Section 66-8-114, NMSA 1978.


